# Booking Information

# Our Company

Any booking is operated by Hipawayvillas behalf of the owners of the properties offered on this web site.

# **Booking Information**

- 1. You must be at least 18 years old to make a booking. Please send us an e-mail or call us in order to confirm availability and current prices, then complete and sign the booking form/short rental agreement sent to you by Hipawayvillas and return it to us. If more than one person is listed on the booking form, the person who sign the booking form acts on behalf of all the person listed and binds them jointly to the terms of such agreement.
- 2. No contract shall exist until full payment has been received and confirmation to this effect has been sent by Hipawayvillas to the tenant. Hipawayvillas has the right to accept or refuse any bookings at its discretion.

# **Deposit & Payment of Balance**

- 1. At the time of booking you will be asked to pay an initial payment of 30% of the total cost of the property. Full payment is required 4 weeks before your holiday commences. If you do not pay the balance of your holiday cost on the due date we reserve the right to treat your booking as cancelled and to levy a cancellation charge in accordance with this terms and conditions. If you book your holiday less than 4 weeks before it is due to commence, the holiday cost is due in full at the time of booking.
- 2, Taxes, if applicable, are not included,
- 3. Payment can be made only by bank transfer.

#### Clarifications

- 1. Arrivals at the property are from 16:00 and departures by 11:00 unless otherwise mentioned on the booking form.
- 2. Details regarding key collection and return will be sent to you by a separate e-mail a week before your arrival.
- 3. The rental includes the provision of bed linen, towels and the use of utilities including water, electricity, heating oil or natural gas.
- 4. Swimming pools, when available, are cleaned and ready for use from May to October.

#### Cleaning

All properties are cleaned and prepared before arrival. Including bed linen and towels.

# Alterations by you

Any alteration by you must be in written. Hipawayvillas will always try to meet your reasonable requirements; however Hipawayvillas may, at its discretion, treat any changes as a cancellation by you and the cancellation fees as set out in this terms & conditions will apply. Furthermore, you will be asked to pay any additional costs incurred by Hipawayvillas in relation to any alteration required.

# **Cancellations**

1. If you wish to cancel your booking you must do so by sending a written notice (by e-mail). Verbal cancellations are not accepted. In case of cancellation by you, cancellation charges are to be paid to compensate for the expense of processing your booking and for any loss that may result from such cancellation as follows:

Written notice of cancellation given:

- 56 or more days prior to rental commencement refund of deposit.
- 28-55 days prior to rental 30% of total holiday cost will be payable.
- 27 or less days prior to rental commencement 100% of total holiday cost will be payble.

or as otherwise agreed on the booking form.

- 2. In case you leave the Property earlier than agreed, no refund shall apply and Hipawayvillas shall be entitled to retain the whole rent as a compensation for your early leaving.
- 3. Hipawayvillas shall not have the right to cancel the booking concluded after total payment has been made, unless it is necessary to do so for reasons beyond our control. Such reasons include war, political unrest, strikes, acts of God, epidemics, riots, civil strife, industrial disputes, terrorist activities, natural and technological disasters (fire, earthquakes etc.), closure of ports and airports. In any such case, Hipawayvillas's liability shall be limited to a refund of the monies already paid.

# **Use of Property**

- 1. The Use of the Property is strictly limited to the number of persons listed in the booking form/short rental agreement. You may use the rented villa pool area, when available, but do so at your own risk.
- 2. The privacy and tranquility of third parties (neighbours etc.) are to be respected by you. Your stay may be terminated if this condition is not met.
